#### DIRECTIONS FOR USE

Vinevax biological wound dressing fungicide may be applied as a spray or brush-on paste.

Spray - Mix Vinevax biological wound dressing fungicide powder with clean water at the rate of 10g per litre. Pre-mix Vinevax biological wound dressing fungicide powder by carefully adding 1000g to 2 litres of water in a clean container, stir to a uniform consistency then make up to 100 litres

For smaller quantities take 100g, pre-mix in 200ml water, then make up to 10 litres with clean water. Stir until thoroughly mixed and allow to stand for 10 minutes before using.

With a hand operated trigger spray or backpack pressure unit, apply Vinevax biological wound dressing fungicide liberally to all pruning cuts and wind damage breaks. Spray to run off on all wounds immediately after wounding. Stir regularly during application.

Brush-on Paste - Mix Vinevax biological wound dressing fungicide powder with clean water at the rate of 100g per litre. Pre-mix Vinevax biological wound dressing fungicide powder by carefully adding 1000g to 2 litres of clean water in a clean container. Mix and make up to 10 litres with clean water. Stir until thoroughly mixed and allow to stand for 10 minutes before using.

With a clean brush apply Vinevax biological wound dressing fungicide liberally to all pruning cuts and wind damage breaks immediately after wounding.

**Notes:** Apply Vinevax biological wound dressing fungicide only to dry surfaces under good drying conditions. Do not apply during rainfall. Ensure there is a 48-hour period between application and the use of fungicidal spray preparations. Mix only what is required: Vinevax biological wound dressing fungicide should be used completely on the day it is made up.

Compatibility: DO NOT use with other pesticides, fertilisers or other materials that may harm the fungus.

Re-entry period: DO NOT allow re-entry into treated areas until the spray or paste has dried. When prior entry is necessary, wear overalls and chemical- resistant gloves. Clothing must be laundered after each day's use.
